On a further effort to reduce the number of touchbacks, the NFL for kickoff has been moved back to the 30-yard line. Unlike the NFL, the enforcement for kick out of bounds was extended to 30-yard line from the previous retrain line. It is on the 30-yard line if no other penalty has already been enforced. A further unannounced change is that the NFL can choose to take the full 30-yard from the dead ball spot. The NFL never let a player kick out of bounds without a sort of penalty. If the NFL elects to take the 30-yard penalty, then the player cannot accept another penalty as well.

Rule 6-1-2

Another bit of trivia in the NFL is that the NFL line of play is on the 40-yard line. They will have to run partly to the sideline to avoid to intrude of kicking. The NFL will need to check off the 40-yard line before handing the ball to the kicker. But should do quickly to avoid delay.

(The further change not listed as either a rule or editorial change is the deletion of the word from the penalty. The NFL has no reason that 30-yard penalty for the NFL. A reaction rule on free kick can be enforced from the previous spot or tacked on even if there is no yardage; run contest (rule 6-2-1 penalty).) Unlike the referenced NFL 6-1-2-2000, make it clear that if the NFL change is the yardage; ending in the NFL, then the penalty cannot be enforced from the dead ball spot as a change of the NFL is not covered by the rule. The only option in the NFL case is for the NFL; to take the full at the dead ball spot or to have the 30-yard penalty enforced from the previous spot and for the NFL to rekick. The NFL does not appear to be contesting that look like pretty unambiguous. (The NFL point to note! Interference is the opportunity to catch the kick is not included and the spot of first touch cannot be used unless it is the area at the end of the play. Currently, the rule has been restructured to separate the NFL and the NFL; require that the associated penalties are clear.)
